CALLING PROCEDURE

Visitor enters flat number onto keypad and presses Bell button  for immediate call.

Or

Visitor enters flat number onto keypad... system waits for a few seconds to make sure that visitor has stopped entering digits and then calls (no need to press Bell button, special feature for blind persons).

Or

Visitor selects using up/down arrows   and presses Bell button .

Visitor call-logging security feature (requirement for Secured By Design 2014 onwards). Full audit trail of day, date, time and duration of all visitor calls to residents including door open authorisations to enable easy identification of any residents abusing the system.
