## CALLING PROCEDURE

Visitor enters flat number onto keypad and presses Bell button  for immediate call.

Or

Visitor enters flat number onto keypad... system waits for a few seconds to make sure that visitor has stopped entering digits and then calls (no need to press Bell button, special feature for blind persons).

Or

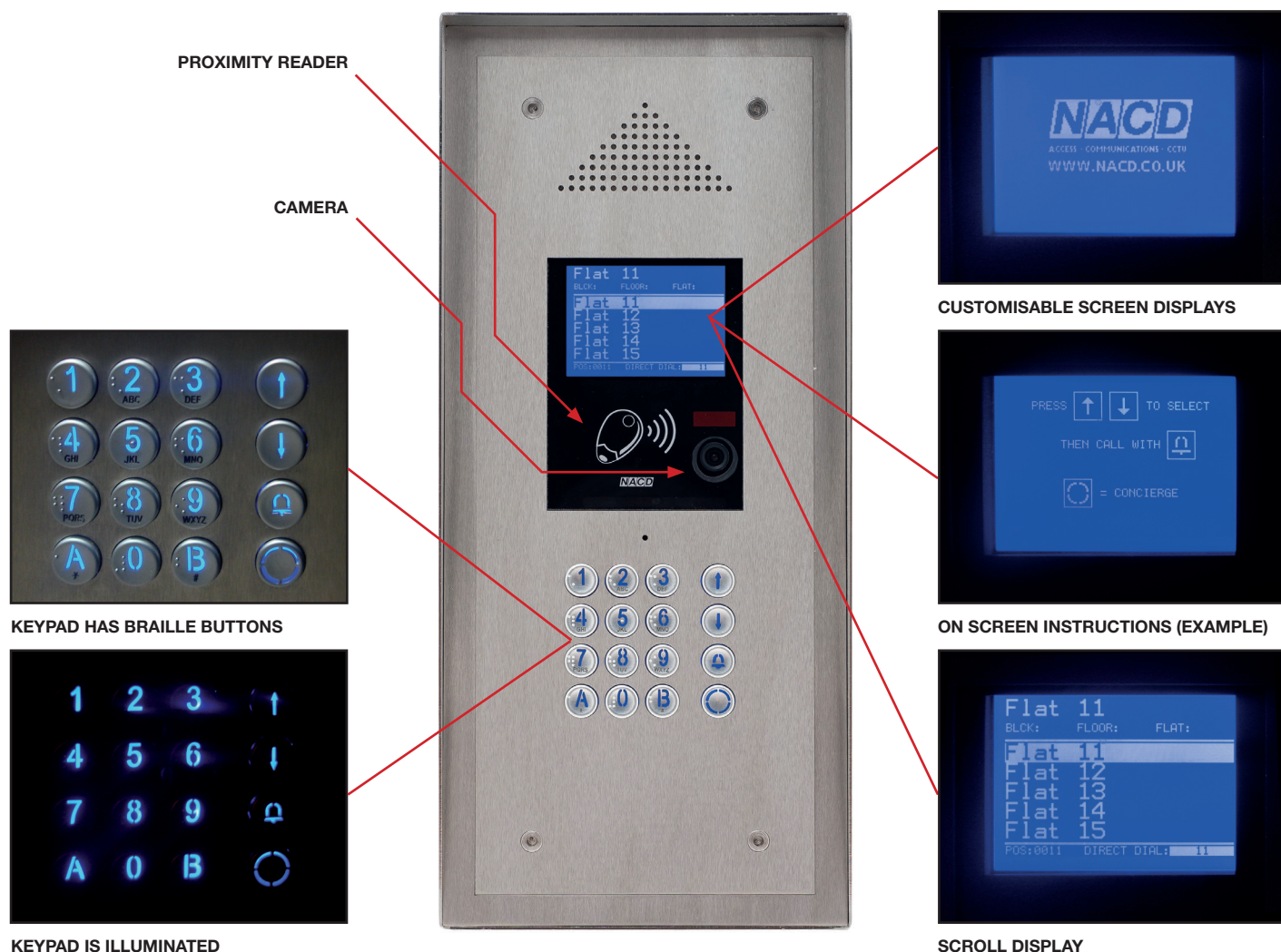
Visitor selects using up/down arrows  and presses Bell button .

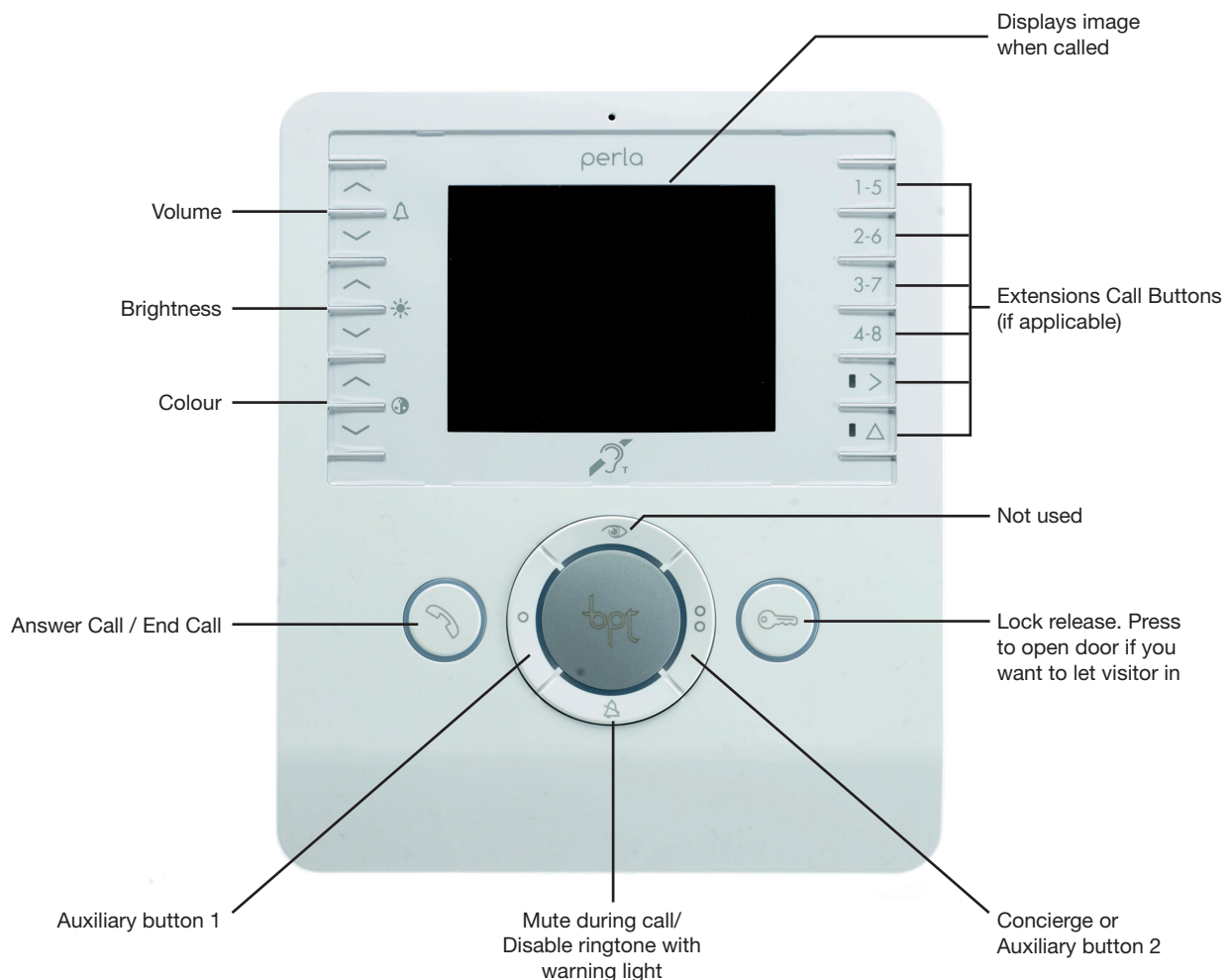

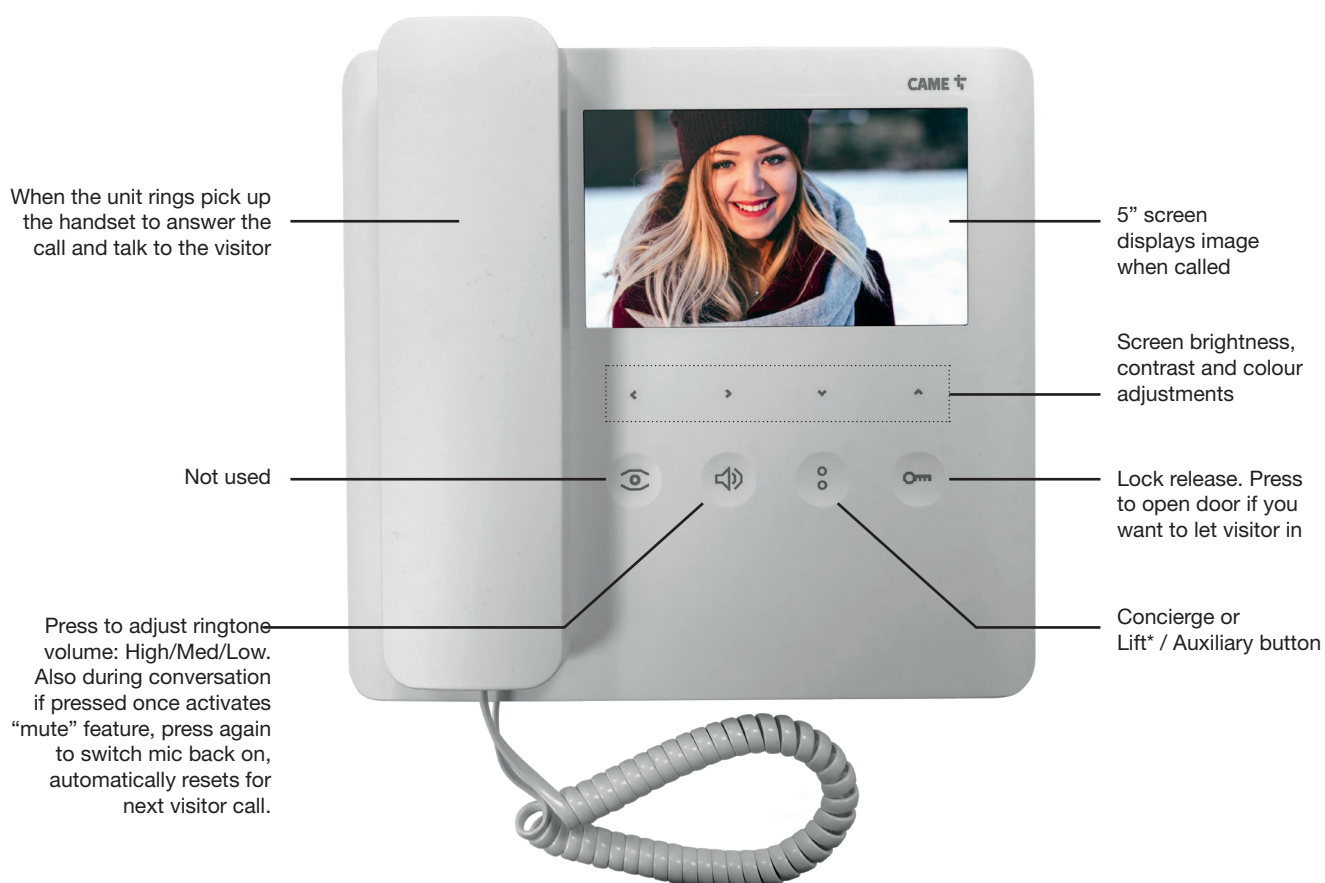
**Perla video monitor is also available in Black.**

When visitors call from the visitor door entry panel, the video monitor will ring and display an image. Press the **Answer Call** / End Call button to talk to them. Only press the Lock Release button if you want to let them in.


Press the Answer Call / **End Call** button to hang up. Your video monitor cannot accept another call until it has finished with the current call. If there is more than 1no visitor door entry panel on your building, **always** press the Answer Call / **End Call** button to hang-up

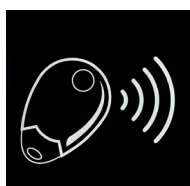
